1. That Chapter 3.38 "Yard Waste User Fee," 3.38.010 "User Fee" Subsection, of the St. Charles Municipal Code be and is hereby amended by deleting the same and substituting the following therefor:

A user fee is hereby imposed upon single family residences or any building that contains six or fewer dwelling units, whether they be occupied or not, in the amount of \$2.00 each month. Said monthly charge shall appear on all residential utility bills beginning **June 1, 2001**.

2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
