ORDINANCE NO. 2001-M- 36

AN ORDINANCE AMENDING TITLE 1, "GENERAL PROVISIONS,"  
CHAPTER 1.28 "WARDS"  
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE  
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 1, "General Provisions," Chapter 1.28, "Wards," Section 1.28.070, "Sixth Ward - Established," and Section 1.28.080, "Seventh Ward – Established," of the St. Charles Municipal Code be and is hereby amended by deleting the same.

2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles. This ordinance shall be effective immediately upon approval.


