

ORDINANCE NO. 2002-M-33

**AN ORDINANCE AMENDING TITLE 10  
"VEHICLES AND TRAFFIC" CHAPTER 10.40  
"STOPPING, STANDING AND PARKING" SECTIONS 10.40.044 AND 045  
"RESIDENTIAL PARKING ONLY" OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic" Chapter 10.40 "Stopping, Standing and Parking", Sections 10.40.044 "Residential Parking Only on School Days", of the St. Charles Municipal Code, be and is hereby amended by adding Muirfield Court, Royal St. James Court and Royal St. George's Court (including the radius of the cul-de-sac);

2. That Title 10 "Vehicles and Traffic" Chapter 10.40 "Stopping, Standing and Parking" Section 10.40.045 "Residential Parking Only" is deleted as a separate Code Section and is added to Section 10.40.044 as subsection C in its entirety.

3. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

4. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.




