**ORDINANCE NO. 2002-M-35**

**AN ORDINANCE AMENDING TITLE 10  
"VEHICLES AND TRAFFIC" CHAPTER 10.11  
"RULES OF THE ROAD" SECTION 10.11.1600  
"THROUGH STREETS" OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic" Chapter 10.11 "Rules of the Road", Section 10.11.1600 "Through Streets", of the St. Charles Municipal Code, be and is hereby amended by adding the following:

- 24. Red Gate Road;
- 25. Dunham Road, excepting its intersection with Foxfield Drive and Kirk Road;
- 26. Tyler Road from Main Street to Kirk Road;
- 27. Dean Street, except at its intersection with Randall Road;
- 28. Smith Road in its entirety.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.
