





ORDINANCE NO. 2002-M- 5

ORDINANCE AUTHORIZING THE SALE OF ITEMS OF PERSONAL
PROPERTY OWNED BY THE CITY OF ST. CHARLES

WHEREAS, in the opinion of at least three-fourths of the Corporate authorities of the City of St. Charles, it is no longer necessary or useful to or for the best interest of the City of St. Charles to retain the personal property now owned by the City of St. Charles and hereinafter;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS AS FOLLOWS:

SECTION ONE: Pursuant to Illinois Compiled Statutes, 65ILCS 5/11-76-4, the City Council finds that the following personal property now owned by the City of St. Charles is no longer necessary or useful to the City of St. Charles and the best interests of the City of St. Charles will be served by its sale:

- 1-Model AVC 80 Microwave System (Serial # E8361)


SECTION TWO: Pursuant to said Section 65ILCS 5/11-76-4, the Purchasing Manager be, and he is hereby authorized and directed to sell the foregoing described personal property now owned by the City of St. Charles as part payment towards the purchase of 1-Model # 92800 Smart System 5 Microwave System from CEM Corp., P.O. Box 200, Matthews, NC 28106-0200.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage, by at least three-fourths of all the corporate authorities, and approval in the manner provided by law.




