



**AN ORDINANCE AMENDING CHAPTER 2.28 "PLAN COMMISSION"  
OF THE ST. CHARLES MUNICIPAL CODE**

WHEREAS, the City of St. Charles has created a Plan Commission and has established its officers and their terms pursuant to 65 ILCS 5/11-12-1 et seq.; and

WHEREAS, the City Council deems it is in the best interest of the City to amend the provisions of Chapter 2.28 "Plan Commission" of the St. Charles Municipal Code with respect to Plan Commission officers;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.28, "Plan Commission" of the St. Charles Municipal Code, be and is hereby amended by deleting Paragraph 2.28.040 thereof and by substituting the following therefor:

**"2.28.040 Officers.**

The Plan Commission shall elect a chairman and such other officers as it may determine, at the first regular meeting in May of each year, or as soon thereafter as may be practicable. In the event of an officer's resignation from that office or from the Commission, the Commission shall elect a replacement officer as soon as is practicable."

2. That after the adoption and approval hereof this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the City Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in


a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on March 4, 2002, the Corporate Authorities of such municipality passed and approved Ordinance No. 2002-M-6, entitled
