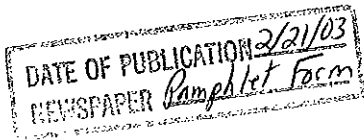

ORDINANCE NO. 2003-M-14

**AN ORDINANCE AMENDING TITLE 10  
"VEHICLES AND TRAFFIC" CHAPTER 10.40  
"STOPPING, STANDING AND PARKING" BY AMENDING  
SECTION 10.40.040 OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10 "Vehicles and Traffic" Chapter 10.40 "Stopping, Standing and Parking", Section 10.40.040 "No Parking Places Designated—Prohibited Parking" of the St. Charles Municipal Code is amended as follows:

- A. T(1)(d) shall read: On the East side of North Third Street starting at a point 33 feet south of Cedar Street and extending Southerly 54 feet from 6:00 a.m. through 10:00 a.m.
- B. T(1)(h) shall read: On the West side of North Third Street starting at a point 41 feet North of Main Street and extending Northerly 60 feet effective 6:00 a.m. - 10:00 a.m.
- C. T(1)(i) shall read: On the South side of Cedar Street from a point 30 feet east of North Third Street extending Easterly for 45 feet.


2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.


