

ORDINANCE NO. 2003-M- 24

**AN ORDINANCE AMENDING CHAPTER 10.41, "HANDICAPPED PARKING,"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter. 10.41, "Handicapped Parking," Section 10.41.050, "Posting signs," of the St. Charles Municipal Code, be and is hereby amended by deleting Paragraph D and replacing as follows:


"D. On-street public parking, South Third Street, with one space on the south end of right of way parking (perpendicular) at 826 and 828 South Third Street located immediately north of the alley on the east side of South Third Street," and
2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
