

ORDINANCE NO. 2003-M- 30

**AN ORDINANCE AMENDING TITLE 10
"VEHICLES AND TRAFFIC" CHAPTER 10.40
"STOPPING, STANDING AND PARKING" SECTION 0.50
"PERMIT PARKING-CITY PARKING LOTS"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10 "Vehicles and Traffic" Chapter 10.40 "Stopping, Standing and Parking", Section 10.40.050 "Permit Parking-City Parking Lots" of the St. Charles Municipal Code, be and is hereby amended as follows:

- C. Parking Lot F. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in the leased portion of the parking lot shown in Exhibit PL-F of this Chapter unless there is displayed in the rear window thereof a reserved parking permit authorized by the City. The foregoing sentence shall apply only to the south portion of the lot as indicated on Exhibit PL-F and shall apply only between the hours of 8:00 a.m. and 5:00 p.m. on Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday.
- D. Parking Lot O. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in the leased portion of the parking lot shown in Exhibit PL-O of this Chapter unless there is displayed in the rear window thereof a reserved parking permit authorized by the City. The foregoing sentence shall apply only between the hours of 8:00 a.m. and 5:00 p.m. on Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday.
- F. Parking Lot Q. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in the leased portion of the parking lot shown in Exhibit PL-F of this Chapter unless there is displayed in the rear window thereof a reserve parking permit authorized by the City. The foregoing sentence shall apply only to the northerly portion of the lot as shown on Exhibit PL-Q and shall apply only between the hours of 8:00 a.m. and 5:00 p.m. on Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty

(30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.
