ORDINANCE NO. 2003-M- 81

**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC,"  
CHAPTER 10.43, "FIRE LANES" BY AMENDING SECTION 10.43.030  
"DISCHARGING CLAIMS" OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.43, "Fire Lanes", Section 10.43.030

"Discharging Claims" of the St. Charles Municipal Code is amended as follows:

Any person accused of a violation of any portion of Section 10.43.020 may settle and compromise the claim against him or her for such illegal parking by paying to the City the sum of \$50.00. If the claim is not settled within 14 days after the ticketing, such person shall have an additional 14 days to settle such claim, but at the sum of \$100.00.

The remainder of the paragraph shall remain the same.


2. That after the adoption and approval hereof, this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.




