

ORDINANCE NO. 2004-M- 16

**AN ORDINANCE AMENDING TITLE 2,
"ADMINISTRATION AND PERSONNEL," CHAPTER 2.26,
"YOUTH COMMISSION," OF THE
ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 2, "Administration and Personnel," Chapter 2.26, "Youth Commission," Section 2.26.030, "Members – Appointment," of the St. Charles Municipal Code, shall be amended by deleting the same and substituting the following therefore:

2.26.030 Members - Appointment.

The seven (7) members of the youth commission shall be appointed by the mayor with the approval of the city council commencing as of May 1, 1967. No more than three (3) of the commission members can reside outside the City limits. The chairman shall be elected by the commission from its own membership. The commission shall also elect as many officers as it may choose.

2. That after the adoption and approval hereof, this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on March 1, 2004, the Corporate Authorities of such municipality passed and approved Ordinance No. 2004-M-16, entitled
