



ORDINANCE NO. 2004-M- 70

AN ORDINANCE AMENDING TITLE 2, "ADMINISTRATION AND PERSONNEL,"  
CHAPTER 2.06, "CITY CLERK,"  
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE  
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 2, "Administration and Personnel," Chapter 2.06, "City Clerk," Section 2.06.140, "Deputy clerk - Appointment - Powers and duties" of the St. Charles Municipal Code, be and is hereby amended by adding Paragraph E therefor:

**2.04.140 Deputy clerk - Appointment - Powers and duties.**

E. In the event of the temporary or permanent incapacity of both the City Clerk and Deputy Clerk, the staff officer designated as acting City Administrator shall have that authority and power described in this section and such further power and authority as may be provided by statute.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles. This ordinance shall be effective immediately.






