





AN ORDINANCE AMENDING TITLE 17
OF THE ST. CHARLES MUNICIPAL CODE
REGARDING TRANSPORTATION/MAINTENANCE FACILITIES
OWNED AND OPERATED BY GOVERNMENTAL AGENCIES

WHEREAS, a Petition has been filed to amend Chapter 17.07 of the St. Charles Zoning Ordinance to add Transportation and Maintenance Facilities Owned and Operated by Governmental Agencies as a Special Use; and

WHEREAS, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with law; and

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

SECTION 1. That Section 17.07.020 "Special Uses" of Chapter 17.07 "E-1 Single Family Estate District" of the Zoning Ordinance be and is hereby amended by adding the following as item "J":

"J. Transportation and Maintenance Facilities Owned and Operated by Governmental Agencies"

SECTION 2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


