ORDINANCE NO. 2005-M - 17

AN ORDINANCE REPEALING TITLE 5“BUSINESS LICENCES AND REGULATIONS” CHAPTER 5.20 “MASSAGE ESTABLISHMENT AND MASSAGE THERAPISTS” OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That effective January 1, 2005 the state legislature put into effect the Massage Licensing Act codified it at 225 ILCS 57/1 et seq. The state Massage Licensing Act gives the State of Illinois Department of Professional Regulation exclusive jurisdiction over the licensing of persons practicing massage or massage therapy.

2. That Chapter 5.20 of the Municipal Code “Massage Therapists and Massage Establishments” in its entirety is hereby repealed.

3. That after the adoption and approval hereof this ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

4. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.




