



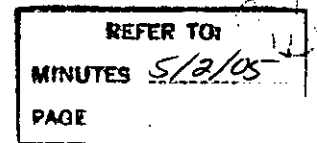

ORDINANCE NO. 2005-M - 21

**AN ORDINANCE AMENDING TITLE 9 "PUBLIC PEACE, MORALS
AND WELFARE" CHAPTER 9.64 "PENALTIES"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 9 "Public Peace, Morals and Welfare" Chapter 9.64 "Penalties" of the St. Charles Municipal Code shall be amended read as follows:

Any person, firm or corporation violating any provision of this title shall be fined not less than \$25.00 nor more than \$750.00 for each offense and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

Further, any person, firm or corporation violating any provision of this Title may also be required to perform some reasonable public service work such as but not limited to the picking up of litter in public parks or along public highways or the maintenance of public facilities.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.





