





ORDINANCE NO. 2005-M-33

AN ORDINANCE AMENDING CHAPTER 8.24 "GARBAGE AND REFUSE"
 OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
 KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 8.24 "Garbage and Refuse," Section 8.24.030 "Collection Services", Paragraph B, "Routes and Schedules" is hereby amended by deleting the same and substituting the following therefore:
2. That Chapter 8.24 "Garbage and Refuse," Section 8.24.040 "Charges and bills" is hereby amended by deleting the same and substituting the following therefor:

"8.24.040 Charges and bills

- A. The charge for collection of each disposal unit or large household item for a non-multifamily dwelling, as defined herein, shall be assessed upon the purchase of a designated bag or sticker, or rental of designated toter. Said designated bags or stickers may be purchased from various retail outlets throughout the city, and designated toters may be rented directly from the contractor at the prices set forth in Section 8.24.040 (B) hereof.
- B. The charges for garbage and rubbish, yardwaste and Recyclable material collection service within the corporate limits of the City shall be as follows:

Toters do not require the use of Refuse bags or stickers.

C. One pre-paid sticker or bag shall be securely and visibly attached to each large household item placed out for collection.

D. 1. Multi-family Units: Bills for the collection of garbage and rubbish and recyclable material to multi-family dwellings being serviced by a dumpster shall be sent out monthly by the City. The due date of bills shall be fifteen (15) days from the date of the billing.

2. Multi-family complexes with twice a week service will be billed by the contracted hauler for the service per week based on the number of occupied units.

E. Late payments shall include an additional ten per cent (10%) charge.


3. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.






I further certify that on June 20, 2005, the Corporate Authorities of such municipality passed and approved Ordinance No. 2005-M-33, entitled
