**An Ordinance Amending Title 10, "Vehicles and Traffic,"
Chapter 10.11.2100, "Intersections where stop or yield required,"
of the St. Charles Municipal Code**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.11.2100, "Intersections where stop or yield required," of the St. Charles Municipal Code, be and is hereby amended by adding the following therefor:

10.11.2100 A


259. On 18th Street at its intersection with Indiana Street so that northbound and southbound traffic on 18th Street must stop.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on October 3, 2005, the Corporate Authorities of such municipality passed and approved Ordinance No. 2005-M-56, entitled
