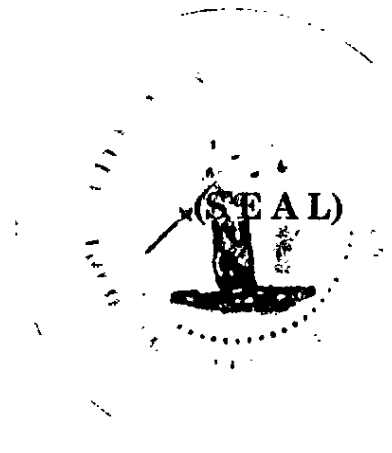

ORDINANCE NO. 2006-M- 16

CITY OF ST. CHARLES, ILLINOIS

AN ORDINANCE AMENDING CHAPTER 2 (BOARD OF TRUSTEES OF THE FIREMEN'S PENSION FUND) OF THE ST. CHARLES MUNICIPAL CODE

WHEREAS, the CITY OF ST. CHARLES (hereinafter the "CITY") has adopted numerous ordinances collectively known as the "Municipal Code" of the City of St. Charles; and

WHEREAS, the CITY has enacted an ordinance governing the membership of the Board of Trustees of the Firemen's Pension Fund for the City of St. Charles; and

WHEREAS, on or about July 25, 2005, P.A. 94-317 amended the Illinois Pension Code (40 ILCS 5/4-121) regarding, *among other things*, the composition and term of office for members of the Boards of Trustees of Firefighter's Pension Funds; and

WHEREAS, the CITY has determined that the Municipal Code of the City of St. Charles should be amended in accordance with the Illinois Pension Code.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the CITY OF ST. CHARLES, as follows:

SECTION ONE: In accordance with Section 5/4-121 of the Illinois Pension Code (40 ILCS 5/4-121), as amended, the term of office of each member of the St. Charles Board of Trustees of the Firemen's Pension Fund shall terminate on the 3rd Monday in April, 2006. Said vacancies shall be filled in conformance with the Illinois Pension Code and the St. Charles Municipal Code, including, but not limited to, Section 2.20.010 as amended herein.

SECTION TWO: The "Municipal Code" of the City of St. Charles is hereby amended by deleting Section 2.20.010 in its entirety and inserting the following language in lieu thereof:

2.20.010 Created - Composition - Election of members.

There shall be a board of trustees of the firemen's pension fund which shall consist of five members: two members shall be appointed by the mayor, two members shall be active participants of the pension fund who are elected from the active participants of the fund, and one member shall be a retired participant who is elected from retired participants, as provided by statute (40 ILCS 5/4-121). The members of the board selected from the active and retired firemen shall be elected at the time and in the manner provided by statute.


SECTION THREE: That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

SECTION FOUR: This Ordinance shall be in full force and effect ten (10) days after publication as required by Law.
