**An Ordinance Amending Title 10, "Vehicles and Traffic,"
Chapter 10.41.050, "Posting signs,"
of the St. Charles Municipal Code**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.41.050, "Posting Signs", of the St. Charles Municipal Code, be and is hereby amended by adding the following therefor:

10.41.050

E. On-street public parking on North Fourth Street with one space on the east side facing northbound at 18 North Fourth Street, immediately north of the main entrance.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on March 6, 2006, the Corporate Authorities of such municipality passed and approved Ordinance No. 2006-M-18, entitled
