ORDINANCE NO. 2007-M- 100

AN ORDINANCE AMENDING TITLE 2, CHAPTER 2.27 "SENIOR SERVICES COMMISSION" OF THE ST. CHARLES MUNICIPAL CODE AND ADDING THERETO A NEW SECTION 2.27.100 "INACTIVE STATUS; SUSPENSION OF COMMISSION ACTIVITIES; REACTIVATION"

WHEREAS, the City of St. Charles (the "City") recognizes the importance of and has had great success addressing issues of concern to senior residents regarding housing, transportation, elder watch care and with programs for seniors through established organizations such as the Salvation Army, Senior Vitality at Delnor-Community Hospital and the St. Charles Park District; and

WHEREAS, the City has established the Vial of Life program and home safety checks through the St. Charles Fire Department and has published the St. Charles Senior Resource Guide and countless other materials; and

WHEREAS, the City has made the aforementioned progress by utilizing the Senior Services Commission established pursuant to the City Code Chapter 2.27; and

WHEREAS, the City acknowledges that the Senior Services Commission has achieved all of its initial goals set forth in the City Code; and

WHEREAS, the Corporate Authorities of the City find it is in the best interests of the City to suspend and deactivate the Senior Services Commission until such time as the Corporate Authorities desire to reactivate the Senior Services Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 2, Chapter 2.27 of the St. Charles Municipal Code, entitled "Senior Services Commission", is hereby amended by adding thereto a new Section 2.27.100 entitled "Inactive Status; Suspension of Commission Activities; Reactivation", as follows:

"2.27.100 Inactive Status; Suspension of Commission Activities; Reactivation.

That the St. Charles Senior Services Commission is hereby placed on inactive status and the activities of said Commission are suspended.

The Mayor with the advice and consent of the City Council may reactivate the St. Charles Senior Services Commission at which time it shall resume the performance of its duties as set forth in Section 2.27.050.”


2. That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


3. This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.


