ORDINANCE NO. 2007-M-15

AN ORDINANCE AMENDING TITLE 2 "ADMINISTRATION AND PERSONNEL", CHAPTER 2.04 "CITY COUNCIL", SECTION 2.04.010, "POWERS AND DUTIES" OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 2, "Administration and Personnel", Chapter 2.04, "City Council Section", Section 2.04.010, "Powers and Duties" of the St. Charles Municipal Code, is hereby deleted in its entirety and in lieu thereof the following language shall be substituted:

"2.04.010 Election – Terms of office – Powers and duties

The members of the City Council shall be elected and serve for a four-year term. The term of the members of the City Council shall commence after the conclusion of old business, if any, at the first regular or special meeting of the corporate authorities in the month of May following receipt of certified election results for the local election authority. The council shall be the legislative division of the city government and shall perform such duties and have such powers as may be authorized by statute."

2. That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


3. This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.


I further certify that on February 20, 2007, the Corporate Authorities of such municipality passed and approved Ordinance No. 2007-M-15, entitled
