CITY OF ST. CHARLES, ILLINOIS

**AN ORDINANCE AMENDING TITLE 8 (HEALTH AND SAFETY)
OF THE ST. CHARLES MUNICIPAL CODE**

WHEREAS, on February 5, 2007, the Mayor and City Council of the City of St. Charles adopted Ordinance 2007-M-9; and,

WHEREAS, Ordinance 2007-M-9 regulated smoking in public places; and,

WHEREAS, the Mayor and City Council of the City of St. Charles have determined that it is in the best interests of the public health, safety and welfare to repeal said ordinance.

NOW THEREFORE, BE IT ORDAINED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, as follows:

SECTION ONE: The foregoing recitals are hereby adopted and incorporated into this Ordinance as if fully set forth herein.

SECTION TWO: Title 8, Chapter 36 of the St. Charles Municipal Code is hereby deleted in its entirety.

SECTION THREE: That all other ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

SECTION FOUR: This Ordinance shall become effective immediately upon adoption and publication.
