**An Ordinance Amending Title 10, "Vehicles and Traffic,"
Chapter 10.40, "Stopping, Standing, and Parking,"
of the St. Charles Municipal Code**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.40.044, "Residential Parking Only on School Days," of the St. Charles Municipal Code, be and is hereby amended by adding the following therefor:

10.40.044

1. The following affected streets...Royal St. James Court, Royal St. George's Court (including the radius of the cul-de-sac) **and Riverview Drive.**

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
