**AN ORDINANCE AMENDING CHAPTER 12.08
OF THE ST. CHARLES MUNICIPAL CODE
(Driveway and/or parking area repair and maintenance)**

WHEREAS, the City Council deems it is in the best interest of the City to amend the provisions of Chapter 12.08 "Driveways and/or Parking Areas in Public Parkway" of the St. Charles Municipal Code, namely (12.08.080)

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 12.08, "Driveways and/or Parking Areas in Public Parkway" of the St. Charles Municipal Code, be and is hereby amended by deleting the 1st Sentence of Section 12.08.080 "**Driveway and/or parking area repair and maintenance.**"

Therefore; Chapter 12.08, Section 080, 1st Sentence, shall hereby be amended to read:

12.08.080 Driveway and/or parking area repair and maintenance.


"It shall be the duty of the person benefiting from the driveway to keep the driveway and driveway approach on public right of way in good repair and free from obstruction and openings."

2. That after adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


