Ordinance No. 2008-M- 33

An Ordinance Amending Title 10, "Vehicles and Traffic,"
Chapter 10.58.200, "Fees",
of the St. Charles Municipal Code

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic," Chapter 10.58.200, "Fees", of the St. Charles Municipal Code, be and is hereby amended by deleting this section in its entirety and add the following:

The Police Department will no less than annually review fees related to towing and set a schedule of fees for use during each fiscal year by Special Order in the Police Department. All other provisions in this chapter shall remain in effect.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on May 5, 2008, the Corporate Authorities of such municipality passed and approved Ordinance No. 2008-M-33, entitled
