


ORDINANCE NO. 2008-M- 46

AN ORDINANCE AMENDING THE ST. CHARLES MUNICIPAL CODE 8.34.020
ORDINANCE VIOLATION FEES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION ONE. That Title 8, Chapter 8.34 "Tobacco Regulation", Section 8.34.020 "Penalties", of the St. Charles Municipal Code, is hereby deleted in its entirety and in lieu thereof the following language shall be substituted:

"8.34.020 Penalties.

Any person violating any provision of this chapter 8.34 shall, upon conviction, be fined fifty dollars (\$50.00) for the first offense, one-hundred dollars (\$100.00) for the second offense and five-hundred dollars (\$500.00) for each subsequent offense. In the alternative, any person violating any provision of this chapter 8.34 shall, upon conviction, complete twelve (12) hours of community service for the first offense, twenty-four (24) hours of community service for the second offense, and one-hundred twenty (120) hours of community service for each subsequent offense. All community service shall be completed within one (1) year from the date of conviction."


SECTION TWO. That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


SECTION THREE. This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.


