

ORDINANCE NO. 2008-M- 49

**AN ORDINANCE AMENDING THE ST. CHARLES MUNICIPAL CODE 9.54.020
ORDINANCE VIOLATION FEES**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

SECTION ONE. That Title 9, Chapter 9.54 "Truancy", Section 9.54.020 "Truancy Prohibited", Subsection E. "Penalty", of the St. Charles Municipal Code, is hereby deleted in its entirety and in lieu thereof the following language shall be substituted:

"E. Penalty:

Any person found guilty of truancy or excessive absenteeism shall be fined fifty dollars (\$50.00) for the first offense during any one (1) school year, one-hundred dollars (\$100.00) for the second offense during any one (1) school year and five-hundred dollars (\$500.00) for each subsequent offense during any one (1) school year. In the alternative, any person found guilty of violating any provision of this chapter 9.54 shall, upon conviction, complete twelve (12) hours of community service for the first offense in any one (1) school year, twenty-four (24) hours of community service for the second offense in any one (1) school year, and one-hundred twenty (120) hours for each subsequent offense in any one (1) school year. All community service shall be completed within one (1) year from the date of conviction."


SECTION TWO. That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

SECTION THREE. This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.


