


ORDINANCE NO. 2008-M- 52

AN ORDINANCE AMENDING THE ST. CHARLES MUNICIPAL CODE 13.16.205
ORDINANCE VIOLATION FEES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION ONE. That Title 13, Chapter 13.16 "Water", Section 13.16.205 "Water Conservation", Subsection D. "Penalties", of the St. Charles Municipal Code, is hereby deleted in its entirety and in lieu thereof the following language shall be substituted:

"D. Penalties: Any person who is found to have violated an order of the City Council or who has failed to comply with any provision of this chapter and the orders, rules and regulations and permits issued hereunder, shall be fined fifty dollars (\$50.00). In addition to the penalties provided herein, the city may recover reasonable attorney's fees, court costs, court reporter fees and other expenses of litigation."

SECTION TWO. That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

SECTION THREE. This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.
