An Ordinance Amending Title 10 "Vehicles and Traffic," Chapter 10.44
"Bicycle Paths," Section 10.44.010, "Bicycle Paths" of the St. Charles
Municipal Code

WHEREAS, community stakeholders identified a need to provide a more robust infrastructure to facilitate pedestrian and bicycle traffic in the 2014 Strategic Plan; and,

WHEREAS, the bike paths infrastructure has expanded since 2005.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION ONE: That Title 10, "Vehicles and Traffic," Chapter 10.44 "Bicycle Paths," Section 10.44.010 "Bicycle Paths" of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefore:

10.44.010 Bike Paths.

The following public ways are designated as bicycle paths as shown in Exhibit 10.44.010.A

SECTION TWO: This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form in the manner provided by law.






