


**Ordinance No. 2011-M-15**

**An Ordinance Amending Title 2, "Administration and Personnel", of the  
St. Charles Municipal Code**

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 2, "Administration and Personnel" of the St. Charles Municipal Code, be and is hereby amended by adding thereto a new Section 2.32.040 as follows:

**2.32.040 Fee for Bail/Bond Administration.**

The Police Department shall charge an administrative fee of fifty dollars (\$50.00) for the processing of bail or bond of an individual in any legal process, civil or criminal, or on any bookable arrest, including any arrest on a warrant.


2. That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance, are to the extent of such conflict, expressly repealed.

3. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
