**An Ordinance Amending Title 8 "HEALTH AND SAFETY,"
Chapter 8.24 "Garbage and Refuse," by adding 8.24.115, "Disconnect
Notice Fee," of the St. Charles Municipal Code**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS
FOLLOWS:

1. That Title 8, "Health and Safety," Chapter 8.24 "Garbage and Refuse," Section 8.24.115, "Disconnect Notice Fee," of the St. Charles Municipal Code, be and is hereby amended by the addition of the following therefore:

8.24.115 Disconnect Notice Fee.


If it is determined that a notice of disconnection of service shall be issued to a customer due to utility charges being over 30 days past due, a payment being returned unpaid by a bank, a deposit not being paid by the due date, and/or a violation of the terms of this Code, an additional fee (a disconnect notice fee) will be charged. This fee will escalate based on the number of disconnect notices previously issued to the customer in the last twelve months. The disconnect notice fee schedule is \$20.00 for the first notice, \$35.00 for the second notice, and \$50.00 for any subsequent notices.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


