




COMPACT VEHICLE PARKING STALLS



 MUNICIPAL PARKING LOT "P"











**Re:** Recommendation to Approve Various Parking Lot Restriction Changes in Downtown Parking Lots

---

The Police Department has been addressing various parking lot restrictions in the downtown area using the Chief of Police emergency powers authorized under 10.040.030 (A). These changes have been made and are being effectively used. They are being recommended to be ordinances as follows:

- 1) **10.40.19 Municipal Parking Lot "I" Plaza Building, First Level** - loading zone added north of the Walnut Street entrance, on the west side of the building next to the gates. This was added to facilitate deliveries to businesses located along First Street Place.
- 2) **10.40.23 Municipal Parking Lot "I" Plaza Building, Fifth Level** – “No Parking Over 2” Snow or Until Cleared”. This was added to facilitate snow removal from the top floor of the parking deck.
- 3) **10.40.24 Municipal Complex Parking Lot "J"**- “No Parking Over 2” Snow or Until Cleared” This was added to facilitate snow removal from the municipal lot. There will be parking available along the east side of the Police Department not covered under this restriction.
- 4) **10.40.26 Municipal Parking Lot "L"** –“Compact Vehicle Parking Only” This restriction is being put in place to facilitate a safer exit from the lot with the tight driveway width.
- 5) **10.40.30 Municipal Parking Lot "P"** – Reserved Municipal Cars Only Monday through Friday 7am-5pm”. This is to change the street name to North Riverside Ave on

the lot exhibit, and to restrict one parking place used daily for the community restitution van, for an adjacency to the office where workers report.

6) **Section 10.40.050 Permit Parking-City Parking Lots.** – This section should be removed. The permit parking was an experiment a few years ago that was not successful. It is no longer used.

The Police Department recommends approval.
