


Ordinance No. 2012-M- 16

**An Ordinance Amending Title 13 “Public Utilities,” Chapter 13.16, “Water,”
Section 13.16.190 “Net Charges for Property with Buildings Connected to
System” of the St. Charles Municipal Code**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, as follows:

Section 1. That Title 13 “Public Utilities”, Chapter 13.16 “Water”, Section 13.16.190 “Net Charges for Property with Buildings Connected to System”, of the St. Charles Municipal Code, is hereby deleted in its entirety and in lieu thereof the following language shall be substituted:

13.16.190 Net Charges for Property with Buildings Connected to System

All property upon which any building has been or may be hereafter erected having a connection with the water system shall pay the following charges:

A. General Water Service

1. Customer Charge. The following customer charge is for all general service water customers:

Customer Charge

Meter Size	Per Month
3/4” and under	\$5.48
1”	\$7.06
1-1/4”	\$8.58
1-1/2”	\$9.88
2”	\$13.34
3”	\$21.19
4”	\$32.34
7-1/2”	\$91.34

2. Water Charge. The following water rates apply to all customers:

Base Water Rate – Two dollars and thirty cents (\$2.30) per 1000 gallons.

*Excess Seasonal Water Rate – Three dollars and eighty-nine cents (\$3.89) per 1000 gallons.

***Excess Seasonal Water Rate applies to customer's first monthly billing period with an ending meter reading date on or after May 15th and the next four succeeding monthly billing periods.**

The excess seasonal water rate applies to water used during the above period which is greater than 130 percent of the monthly average of water used during the winter quarter and which is greater than 6,500 gallons per month usage. All other water is billed at the base rate. New customers who have no history of water consumption during the winter quarter will be billed on the basis of actual consumption during the winter quarter until a winter average is determined."

Section 2. That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law. The rates set forth herein will be effective with the first billing subsequent to June 1, 2012.

Section 3. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
