An Ordinance Repealing Title 15, "Building and Construction", Chapter 15.44, "Fair Housing Regulations", of the St. Charles Municipal Code

BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

Section 1. That Title 15, "Building and Construction", Chapter 15.44, "Fair Housing Regulations", of the St. Charles Municipal Code be and is hereby repealed in its entirety.

Section 2. That after passage and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the City Council, or (ii) within thirty (30) days after passage and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

Section 3. This Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.
