**An Ordinance Amending Title 5 of the St. Charles Municipal Code  
Entitled “Business Licenses and Regulations” Chapter 5.14 Entitled  
“Amusement Game Devices”**

**(Amusement Game Device License Fees)**

WHEREAS, the City Council of the City of St. Charles hereby finds that it is in the City’s best interest to periodically review license fees; and,

WHEREAS, the Government Operations Committee of the City Council reviewed the proposed amendments on or about August 3, 2015; and,

WHEREAS, the Planning and Development Committee of the City Council recommended approval of the proposed amendments on or about August 10, 2015; and,

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Planning and Development Committee and has considered the same:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, as follows:

1. The preambles set forth hereinabove are incorporated herein as substantive provisions of this Ordinance as if fully set out in this Section 1.

2. That Chapter 5.14 Section .015 “Amusement Game Device Arcade.”, is hereby deleted in its entirety.

3. That Chapter 5.14 Section .025 “Maximum Number of Licenses Per Establishment.”, is hereby deleted in its entirety.

4. That Chapter 5.14 Section .060 “License – Fee – Keeping or Displaying Machines for Use”, is hereby deleted in its entirety and replaced by:

“The annual fee for licenses required by Section 5.14.020 shall be:

- A. The fee for establishments with one (1) to five (5) Amusement Game Devices shall be \$100.00
- B. The fee for establishments with six (6) to fifty (50) Amusement Game Devices shall be \$250.00
- C. The fee for establishments with fifty-one (51) or more Amusement Game Devices shall be \$500.00”

5. That after the adoption and approval hereof this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty


(30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

6. This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.


I further certify that on August 17, 2015, the Corporate Authorities of such municipality passed and approved Ordinance No. 2015-Z-19, entitled
