

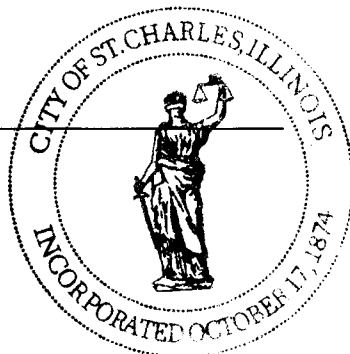

Ordinance No. 2021-M-8**

**An Ordinance Amending Title 3, “Revenue and Finance”, Chapter 3.32
“Hotel Operators Occupation Tax”, Section 3.32.075 “Proceeds” of the
St. Charles Municipal Code**

WHEREAS, the City of St Charles (“City”) has a population of more than 25,000 and is therefore a “Home Rule Unit” under the 1970 Illinois Constitution; and

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt; and

WHEREAS, the City has in full force and effect a codified set of those ordinances of the City which are of a general and permanent nature, which said codified set is known and designated as the Municipal Code of the City of St Charles, as amended; and

WHEREAS, 65 ILCS 5/8-3-14 authorizes the City to impose a Municipal Hotel Operators Occupation Tax, which the City has enacted as Chapter 3.32 of the City’s Municipal Code; and

WHEREAS, the City, as a Home Rule Unit, may utilize the proceeds of the Hotel Operators Occupation Tax for any lawful purpose; and

WHEREAS, the City Council finds it necessary and proper to amend said Code as follows, which this Board finds is in the best interests of the City of St Charles.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS AS FOLLOWS:

Section 1. That Title 3, “Revenue and Finance”, Chapter 3.32 “Hotel Operators Occupation Tax”, of the St. Charles Municipal Code be and is hereby amended to Section 3.32.075 “Proceeds” be amended with the following language:

All proceeds resulting from the imposition of the tax under this chapter, including interest and fines, shall be paid to the treasury of the City of St. Charles and shall be credited to and deposited in the General Fund of the City. Prior to May 1st of each year, the City Council shall determine how the proceeds of the tax shall be utilized for the upcoming fiscal year. Amounts may be distributed to outside organizations in furtherance of the purposes listed below. Should the Council desire to distribute the proceeds to outside organizations, the Council shall distribute the proceeds for the following purposes:

1. Encouragement , advancement, and promotion of tourism and support of activities, programs, organizations, or events that encourage persons to visit the City of St. Charles;
2. Encouragement, advancement, promotion, and support of activities, programs, organizations, or events that support and promote culture, history, entertainment, and the arts in the City of St. Charles.

After determining the amount of the proceeds to be distributed for the purposes referenced in paragraph (1.) and (2.) above, the remaining proceeds shall be retained in the General Fund of the City and expended for any lawful purpose.


Section 2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the City Council of the City of St. Charles.

Section 3. That this Ordinance shall be in full force and effect as of September 1, 2018, approval and publication as provided by law.
